UNLIMITED COMMERCIAL FONT LICENSE

License type	Commercial
Licence cover	- Unlimited use in Print, Web, Media, and App embedding within a single organisation - Unlimted installations
Description	This license grants you the right to use the fonts for commercial purposes. You <i>may</i> install the licensed fonts on every computer, website, and app your company will ever own. You <i>may not</i> share the font files with other parties.

END USER LICENSE AGREEMENT

This End User License Agreement ("Agreement") is a legal agreement between the Licensee, and or the purchaser ("You") and Eino Korkala and Daniel Coull ("Authors"). By purchasing, downloading, installing, and otherwise using the Font Software and the design of the Fonts embodied therein ("Font" or "Fonts"), you agree to the terms of this Agreement.

Upon receipt of full payment of the license fees, the Authors grant You the right to a non-exclusive, revocable license to use the Fonts in accordance with the terms of this Agreement. You do not acquire any ownership rights. All rights not expressly granted to You under this Agreement are reserved by the Authors.

As a Designer, You may acquire a license to the Fonts on behalf of the Licensee. However, the Designer must ensure that the Licensee's name and Company Size are correctly applied during the purchase.

You must ensure that the Licensee accepts and complies with the terms of this Agreement. You may not charge the Licensee more than the original cost of the license.

Outside of the use described in this Agreement, You may not sub-license, distribute, rent, share the Fonts to any third party outside of Your Organisation.

1. DEFINITIONS

"Designer" means an external entity such as a freelance designer, studio, or agency using the Fonts to produce design work on behalf of the Licensee.

"Company Size" means the total number of employees and contractors, across multiple business locations, working for the Licensee.

"Your Organization" means the entity, company, or organization that You are the owner or employee of, across all business locations.

2. OWNERSHIP

You agree that the Fonts and Font software, and the designs embodied therein, are the exclusive property of the Authors, including trademarks, copyrights, and other intellectual property rights. Agreement to this license does not transfer any ownership rights.

3. LICENSE

The license grants You the right to use the Fonts within Your Organization according to the terms of this Agreement.

You may install the Fonts on any number of devices within Your Organisation.

You may use the Fonts on any printed mediums, and on any websites owned by Your Organisation. Any Fonts served on websites must be done using the CSS @font-face rule, and not be downloadable publicly.

You may embed the Fonts into apps and static documents such as PDF, EPS and eBooks within Your Organisation, You must ensure that the Fonts are not accessible or downloadable by its users.

This license covers self-employed third parties who are temporarily working at one of Your business locations on Your devices and are considered part of Your Organization for the purpose of this license.

The cost of the license fee tier is determined by the Company Size, and will remain valid even if the Licensee's employee number increases after the time of purchase.

If any employee or Designer stops working for the Licensee, You must ensure that all copies of the Fonts are destroyed from any devices and storage.

4. LIMITATIONS

You agree to use reasonable measures to ensure that the Fonts are not publicly accessible or downloadable to unlicensed third parties. You may not upload the Fonts to any online storage platforms such as GitHub.

The Fonts may not be used to promote or share any hateful, violent, and discriminatory content or messages based on race, culture, gender identity, sexual orientation, or fascist ideologies. The Authors retain the right to revoke any license which violates this provision and no license fee refunds will be issued.

The Fonts may not be used to train or enhance any artificial intelligence or machine learning models. This includes but is not limited to image or text generation and any other means of re-engineering, replicating, and extracting the Fonts.

Use of the Fonts in any political or religious campaigns, advertising, or media requires prior agreement and written consent from the Authors.

Use of the Fonts in, embedded in, or in promotion of Non-Fungible Tokens or blockchain technologies is prohibited without prior agreement and written consent from the Authors.

5. UPDATES

The Authors may at their discretion release updates or new versions of the Fonts. Any updates are governed by this Agreement.

6. COPIES

You may install and copy the Fonts on all devices within your organization, including temporary copies for use by printers or service providers. These copies must only be used for your organization's purposes and not by third parties outside your organization.

7. MODIFICATIONS

You may use the Fonts to create artwork (such as outlines). You may not rename, modify, adapt, translate, reformat, reverse engineer, decompile, disassemble, edit, alter, or create derivative works based on the Fonts without prior written consent from the Authors. Commissioning third parties to alter the Fonts is also not allowed.

8. DERIVATIVE WORKS

If you create derivative works (artwork, designs, or other materials) using the Fonts, those works are still subject to this Agreement. You may not distribute or sell derivative works that include or embed the Fonts without written permission from the Authors.

9. TRANSFERS

You are permitted to transfer this perpetual license and font software to another legal entity, provided that the new licensee accepts this Agreement in writing and notifies the Authors. If the license is transferred, you must destroy all copies of the font software immediately upon transfer.

10. WARRANTY

The Authors aim to produce Fonts to the latest technical standard with thorough testing. However if the Fonts fail to function, or due to changes, modifications, or updates become wholly or partially inoperative, the Authors shall within 30 days repair or replace the Fonts. Should the issues remain and a remedy not be feasible, the Authors will refund the License fee pertaining to the Agreement, and this Agreement shall terminate immediately.

The Authors own all their rights and ensure the Fonts will not infringe on any third party intellectual property rights. The Authors disclaim all warranties, express or implied, including but not limited to, any warranties of merchantability and fitness for a particular purpose.

This Font software is provided “as is”. The Authors shall in no event be liable for any revenue losses or indirect, incidental, special, consequential damages arising out of the use or inability to use the Fonts, even if given advanced notice. The Authors are not liable for any damages arising from its use, and their liability is limited to, not exceeding, the License fee of the Agreement.

11. TERMINATION

This Agreement is effective in perpetuity until terminated. You may choose to end this Agreement at any point by notifying the Authors of Your intent to terminate, ceasing use of the Font software, and destroying all backup copies. The Authors have the right to terminate Your license to use the Fonts without notice if you breach or fail to comply with the terms herein. Upon termination any use of the Fonts, the Fonts, and any copies must be destroyed, no license fees will be refunded in this case. The Agreement and its rights apply worldwide.

12. LAW

This Agreement shall be governed by and construed exclusively in accordance with the laws of Finland and the exclusive jurisdiction of Finnish courts. No amendments to this Agreement shall be effective unless it is signed by both parties.

The Authors reserve the right to amend and update this EULA Agreement. Modifications will preserve the original usage permissions and any updated versions will be available on publicletters.co.
